

Introduction

India ranks first in having the largest livestock population in the world. Livestock plays an important role in the national economy as well as in the socio economic development. India is emerging as the world's 2nd largest poultry market with an annual growth of more than 14%, producing 61 million tonnes or 3.6 percent of global egg production. The annual growth rate of egg production is 5-8%. Apart from this, India ranks 6th in broiler production with an annual output of 2.39 million tonnes of broiler meat, as per the estimates of the Ministry of Agriculture, Govt. of India.
