

Confidential publications in Pure

Pure infosheet 6, version 14-06-2022

In Pure, there are two ways to specify a publication as confidential. You can mark the file as confidential. The description of the publication will be visible, but the PDF is not downloadable. Or you can set the record in Pure to confidential. In this case, the description of the publication will not be visible anywhere. Other options are not to provide the PDF, or to set an embargo if the confidentiality applies only for a couple of years. Below are the various options.

Publication completely open

In Pure the *Visibility* is set to *Public* and the *Access* to the PDF is set to *Open*. The Pure Team checks the copyright of the PDF and contacts you if in doubt.

Publication visible, PDF not downloadable

In Pure the *Visibility* is set to *Public* and the *Access* to the PDF is set to *Closed*. The description will be public, but the PDF will not. Do not insert the abstract in the Pure record if it shouldn't be made public. The publication will be visible on Research@WUR, the WUR website, and possibly KennisOnline, but the PDF is not downloadable.

Publication completely confidential

In Pure the *Visibility* is set to *Confidential* and the *Access* to the PDF is set to *Closed*. The record in Pure is only accessible to the Pure importer(s) of the research group and the Pure team. The publication is not visible on Research@WUR, the WUR website, KennisOnline, or anywhere else. It is possible to include these records in reportings.

Upload the PDF or not?

If the PDF is confidential, it isn't compulsory to upload the PDF in Pure. In this case, the research group itself is responsible for the permanent storage of the publication. If you do upload the PDF, the Pure team will store the PDF as confidential in the Edepot. On request, it is possible to make the document open later on. The library doesn't make documents public without a request from the researcher or the research group.

PDF under embargo

If the PDF is confidential up to a certain date, it is called an embargo. Set the *Access* to the PDF to *Embargoed* and state the date until the embargo is valid. There is no limit; an embargo can last ten years or even longer. The PDF should not contain 'confidential' or 'vertrouwelijk'. If necessary, request a new PDF from the researcher.

Extra information:

Visibility is located at the bottom of the Pure record. Use only *Public* and *Confidential*. Other options are not correctly processed by the library systems.

The files in Pure will be transferred by the Pure team to the **Edepot** of the library. The access stated in Pure will be taken up as follows:

Open: PDF immediately public

Restricted: access only for WUR employees and students (immediately)

Embargo: PDF public from the stated date

Closed: confidential document, PDF not downloadable

Unknown: do not use, ask the researcher for information, or contact the Pure team

Note: you will not receive an email or alert when the embargo expires.

It is not possible to upload a file in a **press/media** record. Send an email with the PDF to the Pure team.
